**Avoid fines and jail due to the
 Workplace Safety & Health Act Regulations**
 -----It has been expanded to cover "all" workplaces -----

RMAF? If your business has not done a Comprehensive Risk Assessment – You could be in trouble with the law!
 Staff working over-time at you business without obtaining OT exemption? – You could be in trouble with the law!

Many businesses are affected. The good news is that businesses classified as an SME, are provided additional assistance to build capabilities through training-led consultancy, which is co-funded by the government.

Any employer, self-employed person or principal (including contractor and sub-contractor) who fails to comply with the requirements of the WSH (Risk Management) Regulations and is guilty of an offence can be fined up to \$10,000, or \$20,000 and be jailed up to 6 months, for subsequent offence.

As a national employer body and being part of the National Tripartite Partnership the **Singapore National Employers Federation** is organizing this special session, as a FREE service and to assist employers in all industries, as the WSH Act will directly impacts business.
