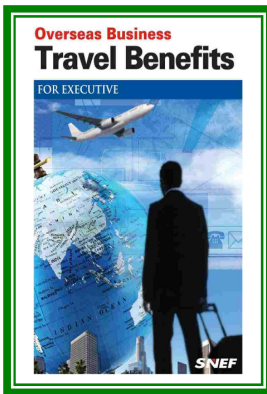




SNEF Overseas Business Travel Benefits For Executive

4. **S**urveyed more than **210** leading employers which employed more than **90,000** employees in Singapore

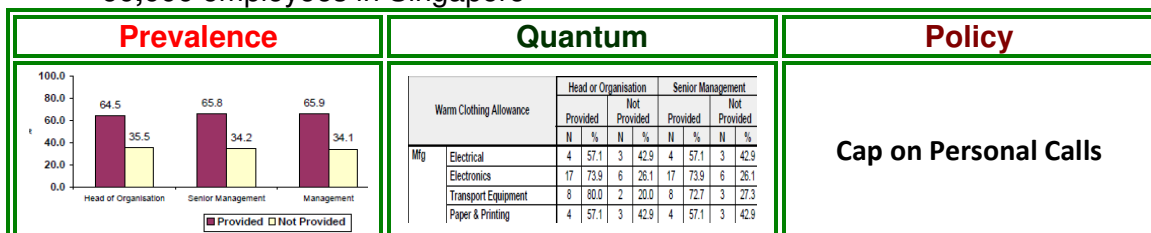


Figure 1: Comprehensive and Representative Information for making informed decisions
